Position overview

The role will manage the planning, execution, and delivery of our social and affordable housing property development projects as well as major capital works projects at existing assets.

Position responsibilities

Project Planning and Coordination:

- Coordinate the development and submission of proposals for new land and funding opportunities.
- Develop comprehensive project plans, including timelines, budgets, and resource allocation.
- Coordinate with internal teams, external consultants, and contractors to make recommendations on project approach, achieve necessary approvals and ensure project milestones are met.

Stakeholder Management:

- Act as the primary point of contact for all project stakeholders, including government agencies and funding bodies.
- Develop and maintain effective collaborative partnerships with external stakeholders including local government, contractors and property related professionals as well as internal Unison teams.



• Ensure effective written and verbal communication and collaboration throughout the project lifecycle.

Risk Management:

- Identify potential project risks and develop mitigation strategies.
- Monitor project progress and implement corrective actions as needed to ensure successful project delivery.

Quality Assurance:

- Ensure all project deliverables meet the required quality standards and comply with relevant regulations, contractual obligations and other guidelines.
- Conduct regular site inspections and audits to maintain high standards of workmanship.

Budget Management:

- Monitor project budgets and expenditures, ensuring projects are delivered within financial constraints.
- Prepare regular financial reports and forecasts for senior management.

Contract Management:

- Oversee the procurement and management of contracts with consultants, contractors, and suppliers.
- Ensure all contractual obligations are met and manage any disputes or issues that arise.

Reporting and Documentation:

- Prepare detailed project reports, including progress updates, risk assessments, and financial summaries.
- Maintain accurate project documentation and records.

Undertake any other work activity as directed by Director Property

Key selection criteria

- Bachelor's degree in project management, construction management, or a related field.
- Demonstrated work experience in project management.
- Strong knowledge of project management methodologies and tools.
- Excellent written and verbal communication, negotiation, and interpersonal skills.
- Proven ability to manage multiple projects simultaneously and deliver results on time and within budget.
- Proficiency in project management software and Microsoft Office Suite.
- Knowledge of relevant regulations and standards in the housing and construction industry.
